WORKSHOP FASHION DESIGN
14th – 28th SEPTEMBER 2016 r.

I. General conditions

1. Workshop Holder is Kielce Technology Park, budgetary unit of Kielce Municipality, Olszewskiego 6, 25-663 Kielce/Poland
2. Administration Office: Kielce Technology Park/Fashion Design Centre, located: Olszewskiego 6, 25-663 Kielce/Poland
3. Workshops will be organised according to the schedule (Attachment no 1 to this Regulation).

5. Workshops are organized under the terms of the Regulation (hereinafter called the "Regulation") and in accordance with the applicable laws.
6. The workshop is addressed to students and graduates of art schools on the course: the clothing design, who meet the conditions of the Regulation
7. The workshop will be held in the period 14th - 28th September 2016 r., wherein the workshop participants can submit their applications from 29nd of June till 16st of August 2016. (In line with the rules described in the " **Workshops conditions:**").

II . Workshops conditions:

Venue: Kielce Technology Park / Fashion Design Centre, address: Olszewskiego 21, Building "OULU" 1st floor, module "F", 25 - 663, Kielce. Participants declare their willingness to participate in the Workshop by sending:

- a correctly completed application form,
- author's portfolio consisting of 10 looks, including min. 2 sketches (the rest photographs) and
- Max 45 second' long movie in English. Video material should be treated as a participant cover letter; brief information about author, his achievements, plans.

1. The evaluation of submitted applications will be done by the Admissions Committee composed of Workshop Mentors and Workshop Holder's delegation.

List of qualified participants will be published on the 22st of August 2016 r. on Workshop Holder webpage www.technopark.kielce.pl . Qualified participants will be informed about decision by e-mail.

II. Terms of Workshops

1. Obligatory rule is of participation in Workshops is sending a correctly completed application form, portfolio and a maximum 45-second movie in English at fashion@technopark.kielce.pl
2. Participation is free of charge.
3. Detailed agenda in attachment to this Regulation.
4. From 13th till 28th of August 2016 r. Workshop Holder will provide participants with accommodation and meals including: breakfast and dinner in all of above mentioned days.
5. Arrival to Kielce is at participant own costs.
6. Registration for workshops in accordance with the provisions of this Regulation is tantamount to placing the participant's statement on the acceptance of the Regulation.
7. Copyright property rights of projects created during the workshops go entirely to the Workshop Holder.
8. The Workshop Holder declares that the personal data of a participant: name, phone number, mobile or landline number and his address, will be processed by the Workshop Holder in order to assure participation in the Workshop and their proper conduction, including the promotion of the event.
9. Workshop participants personal data will be processed and protected in accordance with the Act on personal data protection of August 29, 1997. (Dz. U. z 2002. No. 101, item. 926, as amended).
10. Participant's personal data: name and the name of the country of origin may be published on the Workshop holder website (www.technopark.kielce.pl).
11. Participant application for Workshop sent to the Workshop Holder, is at the same time confirmation that participant has exclusive and unlimited copyright to the submitted work in the portfolio.
12. A prerequisite to participate in the Workshop is to sign the participant's statement on hearing the Regulations (Attachment nb 2 hereto), a statement of authorization to use the name, place of residence, image and participant speech for the purpose of the Workshop and the promotion and Workshop advertising, and consent to the processing of personal data of a participant (Attachment no 3 to the present Regulation).
13. The Workshop Holder reserves himself the right to take a photo and film the participants during the workshop and a right to use photos and footage for promotional purposes of Workshop.
14. No signing of any of the statements mentioned in point. 12, authorizes the Workshop Holder to refuse participate to attend in the Workshop.
15. In matters not covered by these Regulation, relevant are provisions of Polish law.
